Your Rights:

You have the right or option to have consumer disclosures, notices and statements provided to you in paper form. You may withdraw your consent for the provision of electronic consumer disclosures, notices, and statements at any time. This consent to receive electronic disclosures applies to all consumer disclosures, notices and statements provided to you by the Credit Union. If you do withdraw your consent, consumer disclosures, notices, and statements will be provided to you in paper form.

To withdraw your consent, to change your e-mail address with the Credit Union, or to request paper copies of electronic consumer disclosures, notices, and statements, please e-mail tmiller@cuofohio.org. Please check the Credit Union's fee schedule at www.cuofohio.org, under **News and Information** for any fees associated with receiving these documents, or copies of these documents, in paper form. In order to consent to the electronic delivery and receipt of consumer disclosures, notices, statements, and any other documents that would otherwise be provided to you in paper form, you will need the following hardware and software requirements:

Basic System Requirements:

- Computer with Internet access
- E-mail receipt capabilities
- Adobe Acrobat Reader (a link is provided for FREE download if needed)

We Recommend:

- For speed, print statements in black/white, not color
- Use laser or ink jet printer. Dot matrix printers will result in poor quality and readability.
- Archive your statements on a floppy disk or other media for easy retrieval in the event that you experience computer problems.

PLEASE REMEMBER:

Keep the credit union informed of all of your contact information in the event that you change your e-mail service. This will preserve our ability to contact you if necessary, and ensure that your statements and other paper copy mail pieces successfully reach you.
