

## Credit Union of Ohio General Giveaway Rules for Social Media

1. Official Rules: By entering this sweepstakes, participant agrees to abide by the following terms and conditions. No purchase necessary. Purchase will not increase your chances of winning. You must have internet access in order to participate. Void where prohibited.
